# Legislative Update

It was an incredible honor to be sworn in for the start of my second term as state representative for District 28. While we were able to elect a speaker of the house on swearing-in day, the usual excitement around this time was clouded by the organizational chaos surrounding the inability of the state legislature to organize and accomplish the business of the people.

Until we are able to get over this hurdle, unfortunately our legislative efforts will continue to stall, and there is so much important work to do.

I am dedicated to working every day on behalf of my constituents. I am focusing on many opportunities and key issues facing the Commonwealth, including:

**Fiscal Responsibility** — We must lower taxes and spend responsibly - making targeted investments in our economy, schools, and other vital programs and services. As Pennsylvanians face unprecedented inflation and financial pressures, we must drive growth and hold agencies accountable.

Responsible Energy Expansion — In order for Pennsylvania to remain a top energy producer and exporter, we must establish energy independence by investing in the abundant resources we have and licensing new pipeline opportunities. We must end our reliance on foreign adversaries for oil and gas, as well as end our involvement in the job-killing Regional Greenhouse Gas Initiative and instead innovate the future energy economy for our region.

**Educational Choices** — We must fund students first, so every child can have access to the highest quality education the Commonwealth has to offer, regardless of ZIP code. Establishing the Lifeline Scholarship Program, investing in our great teachers and fully funding education programs are essential.

Effective and Efficient Government — The best version of the government is one that works in the best interests of Pennsylvanians first and does not overstep its bounds. This includes advancing voter identification and election integrity reform, limiting the duration of executive orders, ending invasive medical mandates and holding ineffective bureaucracies accountable.

With your cooperation and through the courage of my colleagues, I know that we can form an effective legislature in Harrisburg that will operate effectively again for the people. # **Protecting Our Community**

### **District Initiatives**



In Hampton Township, a registered sexually violent predator recently moved into a residence located immediately adjacent to an elementary school's playground that is used by children at recess.

After meeting with concerned parents, I plan on introducing legislation that would close a loophole in Megan's Law by limiting the residency of these individuals from moving within a certain distance of schools and daycare center locations.

While anyone convicted of a sexually violent offense in Pennsylvania is required to undergo an assessment conducted by the Sexual Offender Assessment Board prior to sentencing, a fraction of these offenders is deemed to have a mental abnormality or personality disorder that makes them unable to control sexually violent impulses and behavior.

Current law requires lifetime sex offender registration; mandatory, monthly sex offender counseling; and active community notification of any change in residence or employment. While residency restrictions can be imposed on sexually violent predators at sentencing, none can be enforced when the sentence concludes.

We must be able to prevent these dangerous behaviors from our communities and children, and I look forward to working with my colleagues on this issue.
